### Eligibility Criteria for GNM Programme : 2018-19

In proviso to the rule 8(5) Karnataka Nurses, Midwives and Health Visitors rule 1964 & Act 1961 it is informed to all the Management/Principals of Schools of Nursing in Karnataka State to follow the following guidelines strictly while admitting candidates to GNM course.

1. Minimum and Maximum age for admission will be 17 and 35 years. There is no age bar for ANM/LHV.
2. **Minimum education:**  
10+2 class passed preferably Science (PCB) & English with aggregate of 40% marks.  
10+2 in Arts (Mathematics, Biotechnology, Economics, Political Science, History, Geography, Business Studies, Accountancy, Home Science, Sociology, Psychology, Philosophy) and English Core/English Elective or Health care Science - Vocational stream ONLY, passing out from recognized Board under AISSCE/CBSE/ICSE/SSCE/HSCE or other equivalent Board with 40% marks.
3. 10+2 vocational ANM under CBSE Board or other equivalent board with 40% marks.
4. Registered as ANM with State Nursing Registration Council.
5. Student shall be medically fit.

6. Students qualified in 10+2 Arts or Science examination or Health care Science-Vocational stream ONLY conducted by National Institute of Open School (NIOS) with 40% marks.
7. **For Foreign nationals:**  
The entry qualification equivalency i.e., 12<sup>th</sup> standard will be obtained by Association of Indian Universities, New Delhi. Institution, State Nursing Council will be responsible to ensure that the qualification and eligibility will be equivalent to what has been prescribed as above.
8. Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government.
9. 5% of total marks is relaxed for SC/ST candidates. Any other reservation as per the State Govt. under the reservations policy. Reservation shall be included in the seats sanctioned and not above it.
10. Student shall be admitted once in a year.
11. Minimum age for admission will be 17 years (as on 31<sup>st</sup> December of that year). The Upper age limit is 35 years.
12. Last Date of admission is 31<sup>st</sup> October 2018.
13. Last date of submission of documents for approval of list is 30.11.2018.
14. Admission Approval List has to submit directly to Karnataka State Diploma Nursing Examination Board through online and hard and soft copy to Karnataka State Nursing Council, Bangalore.
